Screen Auckland Application Processing and Timeframes	<p><b>Filming applications</b> are assessed by Screen Auckland on a case-by-case basis and whilst every effort is made to ensure minimum timeframes for processing are met, these may be subject to change and delay based on the completeness and complexity of the submitted application, impact level, current alert level, and overall demand for service</p> <p><b>Film permits</b> will be issued in accordance with government and ScreenSafe Covid-19 Alert Level Guidelines in place on the day of issuance. If a change in alert level is enacted which will affect the filming activity, the permit will be reviewed and may be amended or rescinded. It will be the responsibility of the film permit holder to contact Screen Auckland and advise a change in alert level may or will affect the filming activity</p>
